#### NASFM and IFMA to Collaborate

President Tyree along with Secretary Dawson met with Butch Browning, the new National Association of State Fire Marshals Executive Director, to discuss opportunities for improved partnerships between the two organizations. While IFMA has State Fire Marshals represented on the Board and in our membership, this opportunity will allow improved communications and teamwork on issues that impact local as well as state fire code officials.

The IFMA Board meeting scheduled for April is planned to be a joint meeting with the NASFM Board to being discussions on topics and programs that may be of interest to both organizations.

Early ideas include collaboration on code change proposals and educational sessions which could be shared across the groups.



### **Chapter Highlights—Fire Prevention Association of Nevada**

#### Highlights of the Chapter 22 Annual Report:

The Association continues to meet its stated purpose and mission by providing training classes to the membership and strengthening the networking and dialogue between various agencies and the fire & life safety industry. These activities will help improve our efforts in ensuring a fire safe Nevada.

Our membership numbers fell slightly from 2021, mainly due to retirements. Two objectives moving forward are to look into returning to in person meetings and to strengthen our fundraising efforts. One of the things that made the Association great was the ability for our members, both jurisdictional and industry, to interact and network in person. By going exclusively to a virtual format, mainly due to the current pandemic, we lost some of those benefits. The Association remains committed to providing several major fire and life safety programs, proudly uphold chapter affiliations with the International Fire Marshals Association and the International Code Council.

Current programs include member training/CEU opportunities through monthly trainings, public education, fireworks testing and hosting off-campus NFA training classes. The association has taken on a leadership role in the adoption process for the 2021 International Fire Code in Southern Nevada. We will assume the leadership role with the adoption of the 2024 IFC later in 2023. We continue to support interagency participation on enforcement, education and safety programs.

#### Fireworks Safety Program:

FPAN members manage the Southern Nevada Fireworks committee, which meet with the local fireworks wholesalers and test "Safe & Sane" fireworks for performance compliance. All fireworks products must be approved by the FPAN committee before they are allowed to be sold over the Fourth of July holiday in Clark County. These members also develop inspection guidelines for fireworks booth sales. All of the testing is completed by April of each calendar year.

#### Youth Firesetter Intervention:

We continue to see growth with our YFSI program. In 2022 we add administrative staff, thru a grant from AmeriCorps to help with intake and record keeping. In 2023, we hope to increase participation from more local jurisdictional partners.

#### Legislation:

The Association is still looking for a bill sponsor to update NRS language for smoke alarm coverage in multi-family occupancies and create new language for single-family residences. We have re-engaged our community stakeholders in order to present a bill that will universally supported. We have a meeting scheduled with our local American Red Cross in support of their "Sound the Alarm" campaign.

#### **Big Issues We Are Dealing With:**

- Membership participation. It continues to be difficult to get members involved in the various
  programs and committees. Most local departments are short staffed so it our goal to provide
  a positive benefit for folks who choose to participate.
- Illegal fireworks. In the last several years, we have seen a large increase in the use of illegal fireworks. Jurisdictions are having a difficult time curtailing this problem due to the huge numbers and a lack of previous enforcement. Public education and enforcement programs will increase this year. While FPAN is not specifically involved, some of our member agencies are participating in an enforcement campaign titled "You light it, we write it!" FPAN will support this measure in the years to come.

## Remembering When is now Steps to Safety

The NFPA **Steps to Safety**<sup>TM</sup> **Prevent Fire and Falls at Home** program pairs fire and EMS professionals with community partners to educate older adults about home fire and fall safety through group presentations, home visits, and the creation of a local resource network. Formerly titled *Remembering When*<sup>TM</sup> *A Fire and Fall Prevention Program for Older Adults*, the updated *Steps to Safety*<sup>TM</sup> (*STS*) program includes an online professional training curriculum and new digitized and print assets to support learning and behavior change for older adults. The approach is one that promotes independence, collaboration, engagement, and empowerment. Rooted in fire and behavioral science and sound educational principles, *STS* provides the framework and tools for fire and EMS professionals and their health and social service partners to impact their community to reduce incidence and injury from home fire and falls.

### This Month in Fire Service History

On 3/4/1908 the Collinwood School (near Cleveland, Ohio) fire (also known as the Lake View School Fire) occurred on Ash Wednesday and killed 172 students, two teachers, and a rescuer. The fire started in the four-story schoolhouse built of ordinary construction when a steam pipe overheated a floor joist. The open stairway allowed the fire to rapidly extend, oiled wooden floors contributed to the fire spread. Panic led to the crush of a large number of students in stairwell vestibules. Doors to the building were equipped with common doorknob latches, not panic hardware.

A misconception is that the doors opened inward, this is not true. "Some crucial circumstanc-

es of the tragedy were almost instantly knowable. The masonry exterior of the building acted as a chimney, sucking flames upward as the wooden interior burned; the school had only two exits, and fire quickly blocked one of them... Collinwood's horse-drawn fire equipment and volunteer fire department were woefully ill-equipped to fight the roaring blaze. It took less than one hour for the three-floor school to burn to the point of collaps-ing into the basement, killing all those inside."


